



海外支部による戸山流居合抜刀道連盟昇段審査運用要領 The Operational Guideline for TIBDR Dan-rank examination Conducted by the Overseas Branches

昇段審査による段位取得の機会が戸山流居合抜刀道連盟連盟(以下「連盟」という。)に所属する会員に等しく与えられている基本的権利であり、戸山流居合抜刀道の普及および技能研鑽を図る上で、意欲向上方策としての段位取得の機会を恒常的に与えることは連盟の重要な責務である。連盟においては、昇段・称号審査委員会(以下「委員会」という。)で指定された昇段審査委員を海外支部に派遣しての昇段審査を行なっているが、海外支部および海外会員が増加していること、更には昇段審査委員の派遣が出来ない諸般の事情等により、海外会員の昇段審査要請に応えられない事態が生じている。依って、これらの事態に対応し海外会員に昇段審査の機会を均等に付与する為に、海外支部長、支部の指導者による、連盟昇段審査基準に基づく昇段審査を実施する為の規定、実施要領を、以下の様に策定し、本運用要領に基づき、海外支部による昇段審査の実施を可能とする。

The opportunity to obtain a Dan-rank through the examination is a basic right that is equally given to members who belong to the Toyamaryu Iai Batto Do Renmei (hereinafter referred to as “TIBDR”). In order to achieve this, it is an important responsibility of TIBDR to constantly provide opportunities to obtain Dan-rank Examination as a motivation-enhancing measure.

TIBDR members who have been designated as the examiners by the Dan-rank and Title examination committee (hereinafter referred to as “The Examination Committee”) has been dispatched to overseas branches to conduct Dan Rank examinations. However, the number of overseas branches and overseas members are increasing. In addition, due to various circumstances (including the current COVID-19 situation) such as the inability to dispatch members, there are situations in which it is not possible to meet the Dan Rank examination requests from the overseas members.

Therefore, in order to respond to these situations and provide equal opportunity to the overseas members, the new rules and implementation details for conducting the Dan Rank examination based on the TIBDR’s Dan Rank examination provision by the overseas branch managers and the leader of the branches (By appointing Senior Designated Dan-rank Examiner and Designated Dan-rank Examiner) shall be formulated as follows, and based on this operational guideline , it will be possible for overseas branches to conduct the Dan Rank examination.



実施要領

Implementation Guidelines

1 指定昇段審査委員

連盟の委員会は、次の条件に適合する海外会員を各指定昇段審査委員に指名したうえで、昇段審査の権限を付与する。

- ① 一級指定昇段審査委員： 練士5段以上の海外会員のうち、委員会が適任と認めた者
- ② 二級指定昇段審査委員： 海外支部の支部長等のうち、委員会が適任と認めた者

1 Appointing the examiners

The Examination Committee shall appoint the overseas members who meet the following conditions as the examiners.

- ① **Senior Designated Dan-rank Examiner (Senior DDE) ;**
Among overseas members who have above 5 Dan with Renshi title and person deemed appropriate by TIBDR committee.
- ② **Designated Dan-rank Examiner (DDE)**
Of overseas branch managers, person deemed appropriate by TIBDR committee.

2 昇段審査権限の範囲

指定昇段審査委員が昇段審査を実施できる段位等の範囲については次の通りとする。

- ① 4段以下 連盟の段位・称号審査委員1名以上と指定昇段審査委員2名以上
- ② 3段以下 一級指定昇段審査委員3名以上
- ③ 2段以下 一級または二級指定昇段審査委員3名以上

2 Range of Dan-rank examination authority

Appointed examiners shall grant the TIBDR Dan Rank Examination authority at the overseas branch's location. And the range of authority for the Dan-Rank examiners are as follows.

- ① Up to 4 Dan test, the test can be carried out with participants of at least one TIBDR committee members and 2 or more Senior DDEs and/or DDEs
- ② Up to 3 Dan test can be carried out with 3 of Senior DDEs
- ③ Up to 2 Dan test can be carried out with 3 of Senior DDEs or DDEs



3 昇段審査実施要領

① 昇段審査および講習会の実施

指定昇段審査委員は相互に協力して昇段審査日および年2回以上の講習会日を設定し、連盟事務局に通知する。講習会参加者の会員手帳に開催日、開催地および責任者の署名を記載して講習会参加状況を明らかにしておく。

② 段位・称号審査申請書

支部長は、昇段審査日までに「段位・称号審査申請書」に被審査会員の必要事項を記入するとともに所定の審査料を徴収すること。

昇段審査を実施するに際しては、連盟が規定する「昇段審査基準」に添った公正な審査を心掛けるとともに、審査状況をビデオ録画しておくこと。

昇段審査終了後、申請書の審査員欄に審査した各指定昇段審査委員の署名を記載するとともに所定の段位登録料を徴収し、録画した USB、申請書、審査料および登録料を連盟事務局に送付する。

③ 級位の審査および認定

級位に関する定めについては、連盟の段位・称号審査に関する規定にないが、海外会員の修練環境を考慮し指定昇段審査委員が独自の基準を定め級位の審査および認定を行うことを認める。なお、級位の認定書等については支部長名で発行するものとする。

3 Dan-rank examination procedure

① Conducting Dan-rank examination and workshop/seminar

Senior DDE / DDE will cooperate with each other to set a promotion examination date, venue and two or more workshop/seminar days a year and must notify TIBDR Secretariat in advance.

The attendance status of the workshop/seminar should be recorded by filling in the date and place of The workshop/seminar and must obtain the signature of the person in charge of the workshop/seminar in the membership passport.

② Dan-rank test application

The branch manager must fill in the required items for the member to be examined in the “Dan-rank examination application form” and collect the prescribed examination fee by the examination dates.

When carrying out the Dan-rank examination, keep in mind a fair examination in accordance with the “The Dan-rank examination criteria” specified by TIBDR, and record each examination scene (Both KATA and TAMESHIGIRI) on video.

After completing the examination, enter the signature of each examiner who has been examined in the examiner's column of the application form and collect the prescribed Dan-rank Registration Fee and collect the recorded media (USB memory or SD memory), application forms, examination fees

and must send all of those to TIBDR secretariat.

③ Sub-Dan (KYU) Grade examination and certification

Sub-Dan grade is not specified in the TIBDR rules, but it is admitted that SDDE/DDE set their own criteria and conduct Sub-Dan (KYU) grade examination and certification in consideration of the training environment of overseas members.

Note: The certificates and other documents may be issued under the name of the branch manager.
